

**The Nottinghamshire County Council (Matlock Street, Meadow Road and The Elms, Netherfield) (Prohibition of Waiting) Traffic Regulation Order 2021 (7241)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respect of roads at Netherfield in the Borough of Gedling: -

Vehicles will be prohibited from **Waiting At Any Time** along the following lengths of road: -

**Matlock Street, Netherfield** (the north-east side)

- From its junction with Meadow Road in a north-westerly direction for a distance of 10 metres.

**Matlock Street, Netherfield** (the south-west side)

- From its junction with Meadow Road in a north-westerly direction for a distance of 10 metres.

**Meadow Road, Netherfield** (the north-west side)

- From its junction with Matlock Street in a south-westerly direction for 10 metres.
- From a point 10 metres south west of its junction with The Elms in a north easterly direction to a point 10 metres north-east of the same junction.

**The Elms, Netherfield** (the north-east side)

- From its junction with Meadow Road in a north-westerly direction for a distance of 10 metres.

**The Elms, Netherfield** (the south-west side)

- From its junction with Meadow Road in a north-westerly direction for a distance of 10 metres.
