

The Nottinghamshire County Council
(Nottingham Road Area, Gotham – Various Locations)
(Prohibition of Waiting) Traffic Regulation Order 2021 (8335)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Gotham in the Borough of Rushcliffe: -

1 Vehicles will be prohibited from **Waiting At Any Time** along the following lengths of road: -

Meadow End, Gotham (both sides)

- From its junction with Nottingham Road in a south -easterly direction for 10 metres.

Nottingham Road, Gotham (the south-east side)

- From a point 10 metres south-west of its junction with Wallace Street in a north-easterly direction to a point 10 metres north-east of that junction.
- From a point 10 metres south-west of its junction with Meadow End in a north-easterly direction to a point 10 metres north-east of that junction.

Wallace Street, Gotham (both sides)

- From its junction with Nottingham Road in a south-easterly direction for 10 metres.

2 Vehicles will be prohibited from **No Waiting Mon-Sat 8am-6pm** along the following length of road: -

Nottingham Road, Gotham (the south-east side)

- From a point 10 metres south- west of its junction with Wallace Street in south-westerly direction for 71 metres.
