**RAMBLERS CLOSE AND JUNCTIONS ON CROSSLANDS MEADOW, COLWICK –  
PROPOSED PARKING RESTRICTIONS –  
DOUBLE YELLOW LINES (TRO 7270) – PUBLIC CONSULTATION**

Via East Midlands Ltd, is working on behalf of Nottinghamshire County Council to deliver highway services in Nottinghamshire. In June 2023 an initial consultation was carried out to obtain the views of residents living in the vicinity of the proposals. Several comments were received during the initial consultation but after due consideration it has been decided to proceed with the scheme as originally proposed.

It is proposed to introduce double yellow lines (no waiting at any time) at the following locations in Colwick:-

- West side of Ramblers Close
- Junction of Ozier Holt and Crosslands Meadow
- Junction of Egling Croft and Crosslands Meadow
- Junction of Fox Covert and Crosslands Meadow
- Junction of Parsons Meadow and Crosslands Meadow
- Junction of Little Ox and Crosslands Meadow
- Junction of Swan Meadow and Crosslands Meadow
- Junction of Pool Meadow and Crosslands Meadow

The proposed double yellow lines will help to ensure that parked vehicles do not restrict visibility for vehicles turning in or out of the junctions. The restrictions will also ensure that there is a clear route for pedestrians to cross the road. The locations of the restrictions are shown on the enclosed drawings (H/JAB/4357/01 to 07) and notice.

Before proceeding further with the proposed parking restrictions, I wish to consider the views of residents and organisations who may be interested in this matter. If your comments are in the form of an objection to the proposals and if they cannot be resolved, they will be reported through the County Council's procedures at the appropriate time. Any observations on these proposals should reach me by **1<sup>st</sup> November 2023**.
