**HIGH STREET AND MATTERSEY ROAD, EVERTON –  
PROPOSED REVISED DOUBLE YELLOW LINES (NO WAITING AT ANY TIME) - (TRO1248)**

The consultation for this scheme was originally advertised in January 2020. This revised consultation has been delayed due to the restrictions imposed by the coronavirus measures which meant that the consultation documents could not have been viewed at the local library or County Hall. The Government has since relaxed the requirement to have the documents on deposit. The full set of consultation documents, for the revised scheme, can now be viewed on either the Nottinghamshire County Council website or they can be sent to you by post or e-mail on request.

As a result of the responses received to the consultation for the double yellow lines on High Street it is now proposed to make some changes to the original scheme. The proposed changes are as shown below and on the enclosed plan:-

- East side of High Street - Extend existing double yellow lines by approx. 5 metres to remove a bottleneck at the junction with Gainsborough Road
- Opposite Metcalfe Court – Introduce additional double yellow lines to enable vehicles an unobstructed access into and out of Metcalfe Court. The lines will also give more room for larger vehicles travelling along High Street.

All previous objections to the scheme will be carried forward unless we receive a response withdrawing the objection.

Before proceeding further with the revised proposals, I wish to consider any further views from residents, businesses and organisations who may be interested in this matter. If your comments are in the form of an objection to the proposals and if they cannot be resolved, they will be reported through the County Council's procedures at the appropriate time. Any observations on these proposals should reach me in writing, either by letter (address at bottom of letter) or email, by **24<sup>th</sup> July 2020**.
