

**The Nottinghamshire County Council (Slack Walk and Alderson Road Area,  
Worksop)(Prohibition of Waiting and Parking Places)Traffic Regulation Order 2020  
(1246)(Revised)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in Worksop in the District of Bassetlaw:-

1. **to prohibit waiting at all times** at the following locations
  - i. Junction of Slack Walk and Garbsen Court
  - ii. Humphries Gardens – along north side up to the boundary of No.s 1 and 3
  - iii. Humphries Gardens – around turning head
  - iv. Junction of Slack Walk and Hartland Road (including O/S No.s 22 and 27)
  - v. Hartland Road – outside No.s 4 to 8
  - vi. Hartland Road – outside No.s 19 and 21
  - vii. Junction of Alderson Road and Slack Walk
  - viii. Junction of Alderson Road and Alder Close
  - ix. Junction of Alderson Road and Chestnut Close
  - x. Junction of Alderson Road and Sycamore Close.
  
2. **to prohibit waiting on – Monday to Saturday between 8am – 6pm**
  - i. Humphries Gardens – from O/S the boundary of No.s 1 and 3 to the end of road
  - ii. Humphries Gardens – Outside No.s 2 to 8
  - iii. Alder Close – around end of cul-de-sac
  
3. **Parking bays–Mon to Sat between 8am – 6pm, 2 hour parking, no return within 1 hour**
  - i. Humphries Gardens – between No. 8 and turning head (approx. 15m long)
  - ii. Humphries Gardens – between turning head and end of road (approx. 11m long)

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such as County Hall and libraries are closed or if reopened will have restrictions in place.

The restrictions are intended to promote safe parking patterns by prohibiting parking on bends and junctions. In addition, it is proposed to provide 2 parking bays on Humphries Gardens (for up to 2 hours) for short-term parking. These proposals are a revision to the consultation that was sent in January/February 2020.

Written objections (stating grounds & quoting ref. 1246) must be received by me by the **23rd October 2020.**
