**ROADS OFF SLACK WALK AND ALDERSON ROAD, WORKSOP –
REVISED WAITING RESTRICTIONS AND PARKING BAYS - (TRO 1246)**

Via East Midlands Ltd, working on behalf of Nottinghamshire County Council, has received numerous responses to the consultation that was previously advertised in January 2020. As a result it has been decided to make some changes to the original scheme. The proposed changes are listed below

- Removal of the 2 hour parking bays from Slack Walk and 1 bay from Humphries Gardens – to reduce the all day parking pressures on the surrounding roads and to give local residents more opportunities to park during the day.
- Extension of proposed double yellow lines (no waiting at any time) – across driveways of 22 and 27 Slack Walk, across frontage of 8 Hartland Road and across part of 19 Hartland Road
- Introduction of single yellow lines to Alder Close -no waiting on Monday to Saturday between 8am and 6pm – the restriction is intended to keep the road clear of parked vehicles for access to properties but still allow parking for residents and visitors in the evenings and all day on a Sunday.

The proposed changes are to remove the previously proposed parking bays from where there are no residential properties. The revised restrictions will mean that the number of on-street parking spaces on Slack Walk, between Humphries Gardens and Westgate, will be unchanged. The proposed additional parking restrictions (single and double yellow lines) are to discourage parking where it is causing access problems for local residents.

Objections received to the original scheme will not be automatically carried forward. If you objected to the original scheme and wish that objection to still be considered in relation to the revised scheme, please contact me in writing to confirm that.

The revised consultation has been delayed due to the restrictions associated with the coronavirus. The consultation documents will not be placed on deposit at County Hall and the local library as was done previously but will instead be available on the NCC website or by post (for further details please see the enclosed Notice)

Before proceeding further with the revised proposals, I wish to consider any further views of residents, businesses and organisations who may be interested in this matter. If your comments are in the form of an objection to the revised proposals and if they cannot be resolved, they will be reported through the County Council's procedures at the appropriate time. Any observations on these proposals should reach me in writing, either by letter (address at bottom of letter) or email, by **23rd October 2020**.
