## PROPOSED DOUBLE YELLOW LINES (NO WAITING AT ANY TIME) AND SCHOOL KEEP CLEAR (NO STOPPING MONDAY TO FRIDAY – 8AM TO 4.30PM) RESTRICTIONS ON JUNCTIONS OFF WESTDALE LANE, PLAINS ROAD AND DIGBY AVENUE, MAPPERLEY. (7215) – PUBLIC CONSULTATION

Via East Midlands Ltd, working on behalf of Nottinghamshire County Council, is proposing to introduce double yellow lines (no waiting at time) restrictions at the following junctions

- Plains Road and Hazel Grove
- Plains Road and Steedman Avenue
- Hazel Grove and Digby Avenue
- Westdale Lane West and Grover Avenue
- Westdale Lane West and Hazel Grove
- Digby Avenue and College Road
- Digby Avenue and Lambley Avenue
- Digby Avenue and Shelford Road
- Digby Avenue and Holyoake Road

The restrictions are being introduced to ensure that the junctions are kept clear of parked vehicles to allow unobstructed crossing points for pedestrians, especially children attending the local schools. In addition the restrictions would give better visibility for vehicles turning in or out of the junctions. The junctions are on routes used by pupils attending the local schools on Hazel Grove and Digby Avenue.

On Hazel Grove, outside the Hazel Hurst Preparatory School, it is proposed to make the existing 'School Keep Clear' markings enforceable to prevent vehicles from stopping near the entrance on Monday to Friday between 8am and 4.30pm. These measures would improve access for children attending the school and ensure that the area outside the school is kept clear.

Before proceeding further, I wish to consider the views of residents, businesses and organisations who may be interested in this matter. If your comments are in the form of an objection to the proposals and if they cannot be resolved, they will be reported through the County Council's procedures at the appropriate time. Any observations on these proposals should reach me in writing, either by letter (address at bottom of letter) or email, by 2<sup>nd</sup> August 2019.
