

## The Nottinghamshire County Council ((A611)Annesley Cutting, (A611 and B6011)Annesley Road and (A611) Hucknall By-Pass in Annesley, Hucknall and Linby) (50 M.P.H. Speed Limit) Order 2021 (4271)

The Council of the County of Nottinghamshire ("the Council") in exercise of its powers under Sections 82(2) and 83(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- No person shall drive any vehicle at a speed exceeding 50 miles per hour on that length of road in Linby in the Borough of Gedling and in Annesley and Hucknall in the District of Ashfield as specified in the Schedule of this Order.
- 2. This Order may be cited as "The Nottinghamshire County Council ((A611)Annesley Cutting, (A611 and B6011)Annesley Road and (A611) Hucknall By-Pass in Annesley, Hucknall and Linby) (50 M.P.H. Speed Limit) Order 2021 (4271)" and shall come into force on the **10th** day of **May 2021**.
- 3. The effect of the following Order insofar as it relates to that length of road specified in the Schedule to this Order is hereby revoked:-
  - "The Nottinghamshire County Council (Hucknall Bypass)(Speed Limits) Order 1994 (487)"
- 4. The effect of the following Order insofar as it relates to that length of road specified in the Schedule to this Order is hereby revoked:-
  - "The Nottinghamshire County Council (A611 Annesley Road, Annesley)(Derestriction) Order 2006 (4079)"

## SCHEDULE

1. Annesley Cutting (A611) in Annesley in the District of Ashfield

- (i) from its junction with Hucknall Road in a north-westerly direction for a distance of 126 metres.
- 2. Annesley Road (A611 and B6011) in Linby in the Borough of Gedling and Annesley in the District of Ashfield
- (i) from a point 67 metres north-west of the give way line to the roundabout junction with Wighay Road (as measured along the north-eastern kerb line) in a north-westerly direction to its junction with Hucknall Road.
- (ii) (A611 Annesley Road northbound carriageway) from its junction with Hucknall Road in a north-westerly direction for distance of 18 metres.
- 3. Hucknall By-pass (A611) in Hucknall in the District of Ashfield
- (i) from the roundabout junction (outer perimeter) with Annesley Road in a southerly direction for a distance of 71 metres.
