

**The Nottinghamshire County Council (Arnold Lane, Colliery Way
(Gedling Access Road), Mapperley Plains and Spring Lane,
Arnold, Lambley and Mapperley)(30 M.P.H. Speed Limit)
Restricted Road Order 2022 (7248)**

The Council of the County of Nottinghamshire ("the Council") in exercise of its powers under Sections 81, 82(2) and 83(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. The length of road specified in the Schedule to this Order shall be a restricted road for the purposes of Section 81 of the Act.
2. The lengths of road specified in the Schedule to this Order shall be revoked from "The Nottinghamshire County Council (Plains Road and Mapperley Plains, Arnold) (40 M.P.H. Speed Limit) Order 1978"
3. The lengths of road specified in the Schedule to this Order shall be revoked from "The Nottinghamshire County Council (Spring Lane and Lambley Lane, Mapperley Plains and Lambley)(40 M.P.H. Speed Limit) Order and (Spring Lane, Lambley)(30 M.P.H. Speed Limit) Order 2013 (7143)"
4. Any previous speed limit order made under the Road Traffic Regulation Act 1984 or any enactment replaced by that Act in so far as it related to the lengths of road specified in Schedule to this Order is hereby revoked.
5. This Order may be cited as "The Nottinghamshire County Council (Arnold Lane, Colliery Way (Gedling Access Road), Mapperley Plains and Spring Lane, Arnold, Lambley and Mapperley)(30 M.P.H. Speed Limit) Restricted Road Order 2022 (7248)" and shall come into force on the **13th** day of **June 2022**.

SCHEDULE

Arnold Lane in Mapperley in the Borough of Gedling.

from its junction with Mapperley Plains in a south-easterly direction for a distance of 31 metres.

Colliery Way (Gedling Access Road) in Mapperley in the Borough of Gedling

from its junction with Mapperley Plains in a south-easterly direction for a distance of 41 metres.

Mapperley Plains (B684) in Mapperley and Arnold in the Borough of Gedling

from its junction with Plains Road (B683) in a north-easterly direction to a point 81 metres north-east of its junction with Spring Lane, as measured along the centre line.

Plains Road (B684) in Mapperley and Arnold in the Borough of Gedling

from a point 98 metres south-west of the south-western kerb line of Gedling Road (A6211) in a north-easterly direction to its junction with Mapperley Plains (B683).

Spring Lane in Lambley and Mapperley in the Borough of Gedling

from its junction with Mapperley Plains (the outer perimeter of the mini-roundabout) in south-easterly direction for a distance of 42 metres (as measured along the centre line)
