

## The Nottinghamshire County Council (Belvoir Road, Chandos Street, Clumber Avenue and Midland Grove, Netherfield)(Prohibition of Waiting) Traffic Regulation Order 2021 (7242)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council HAS MADE an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in Netherfield in the Borough of Gedling:-

## Proposed No waiting at any time restrictions (double yellow lines) at the following locations:-

- 1. (i) <u>BELVOIR ROAD (NETHERFIELD) (both sides)</u> from its junction with Chandos Street in a south-easterly direction for 5 metres.
  - (ii) <u>CHANDOS STREET (NETHERFIELD) (the north-west side)</u> from a point 5 metres south-west of its junction with Midland Grove in a north-easterly direction to a point 5 metres north-east of same junction.
  - (iii) CHANDOS STREET (NETHERFIELD) (the south-east side) from a point 5 metres south-west of its junction with Clumber Avenue in a north-easterly direction to a point 5 metres north-east of the same junction.
  - (iv) from a point 5 metres south-west of its junction with Belvoir Road in a northeasterly direction to a point 5 metres north-east of the same junction.
  - (v) <u>CLUMBER AVENUE (NETHERFIELD) (both sides)</u> from its junction with Chandos Street in a south-easterly direction for 5 metres.
  - (vi) MIDLAND GROVE (NETHERFIELD) (both sides) from its junction with Chandos Street in a north-westerly direction for 5 metres.

The double yellow lines have been introduced to remove parked vehicles from the junctions above. The restrictions will give better visibility for vehicles turning into or out of the junctions and will also give an unobstructed route for pedestrians to cross the road.
