

<u>The Nottinghamshire County Council (Gonalston Lane, Gonalston and Hoveringham) (Prohibition and Restriction of Waiting)</u> <u>Traffic Regulation Order 2023 (3361A)</u>

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council HAS MADE an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in Gonalston and Hoveringham in the District of Newark and Sherwood:-

1. No waiting at any time restrictions (double yellow lines) on Gonalston Lane, Hoveringham:-

GONALSTON LANE (the north-east side)

- (i) from a point 207 metres south-east of the centre line of the Nottingham to Newark railway line (a point in the centre of the 2 running lines) in a south-easterly direction for 27 metres.
- (ii) from a point 260 metres south-east of the centre line of the Nottingham to Newark railway line (a point in the centre of the 2 running lines) in a south-easterly direction for 252 metres.
- (iii) from a point 180 metres north-west of the centre line of its junction with Bradleys Lane in a north-westerly direction for 386 metres.

GONALSTON LANE (the south-west side)

- (iv) from a point 207 metres south-east of the centre line of the Nottingham to Newark railway line (a point in the centre of the 2 running lines) in a south-easterly direction for 36 metres.
- (v) from a point 260 metres south-east of the centre line of the Nottingham to Newark railway line (a point in the centre of the 2 running lines) in a south-easterly direction to a point 180 metres north-west of a point opposite the centre line of its junction with Bradleys Lane.

The double yellow lines are to remove parked vehicles from Gonalston Lane, especially from the grass verges. The removal of parked vehicles would make it safer for drivers using Hoveringham Lane and would reduce the damage to the verges. The existing informal parking areas would still be available for parking. The originally proposed double yellows, to 200 metres either side of the level crossing, will completed at a later date.

THE ORDER WILL COME INTO FORCE ON THE 28th DAY OF JUNE 2023.
