

**The Nottinghamshire County Council (Laneham Road, Dunham on Trent, Laneham, Rampton and Stokeham and Rampton Road, Treswell) (50 M.P.H. Speed Limit) Order 2023 (1277)**

The Council of the County of Nottinghamshire ("the Council") in exercise of its powers under Sections 81, 82(2) and 83(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. No person shall drive any vehicle at a speed exceeding 50 miles per hour on those lengths of road in Dunham on Trent, Laneham, Rampton, Stokeham and Treswell in the District of Bassetlaw as specified in the Schedule of this Order.
2. Any previous speed limit order made under the Road Traffic Regulation Act 1984 or any enactment replaced by that Act in so far as it related to the lengths of road specified in Schedule to this Order is hereby revoked.
3. This Order may be cited as "The Nottinghamshire County Council (Laneham Road, Dunham on Trent, Laneham, Rampton and Stokeham and Rampton Road, Treswell) (50 M.P.H. Speed Limit) Order 2023 (1277)" and shall come into force on the **8th** day of **March 2023**.

**SCHEDULE**

**Dunham Road, Laneham**

from its junction with Laneham Road in a north-easterly direction for a distance of 69 metres.

**Laneham Road in Dunham on Trent, Laneham, Rampton and Stokeham**

from a point 579 metres north of its junction with A57 Darlton Road in a northerly, north-westerly, northerly and then north-easterly direction to its junction with Rampton Road, Treswell (an approximate distance of 5744 metres).

**Main Street, Laneham**

from its junction with Laneham Road in a north-easterly direction for a distance of 25 metres.

**Main Street, Stokeham**

from its junction with Laneham Road in a westerly direction for a distance of 22 metres.

**Rampton Road in Treswell**

from its junction with Laneham Road in northerly direction to its junction with Cottam Road.
