

THE NOTTINGHAMSHIRE COUNTY COUNCIL ROAD TRAFFIC REGULATION ACT 1984

THE NOTTINGHAMSHIRE COUNTY COUNCIL (ARNOLD LANE, BURTON ROAD, COLLIERY WAY (GEDLING ACCESS ROAD) AND LAMBLEY LANE, GEDLING)(40MPH SPEED LIMIT AND RESTRICTED ROAD) ORDER 2022 (7223)

The Council of the County of Nottinghamshire ("the Council") in exercise of its powers under Sections 81, 82(2), 83(2), 84(1) and 84(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

- 1. No person shall drive any vehicle at a speed exceeding 40 miles per hour on that length of roads specified in Schedule 1 of this Order.
- 2. The length of road specified in the Schedule 2 to this Order shall be a restricted road for the purposes of Section 81 of the Act.
- 3. The following Order is to be revoked in whole "The Nottinghamshire County Council (Arnold Lane, Gedling)(40mph Speed Limit) Order 1995 (7020).
- 4. The following Order is to be revoked in part "The Nottinghamshire County Council (Nottingham Road Lay-by, Burton Joyce; Burton Road, Colwick Loop Road, New A612 Road, Road No.1, Stoke Lane, Victoria Parkway and Victoria Road, Carlton; Colwick Loop Road, Colwick and Stoke Lane, Stoke Bardolph)(30 M.P.H. and 40 M.P.H. Speed Limits) Order 2007 (7091)" part to be revoked is Schedule 3 Part (a), Item 1.
- 5. The following Order is to be revoked in part "The Nottinghamshire County Council (Lambley Lane, Gedling)(30 and 40mph Speed Limits) Order 2014 (7166) Schedule 2 to be revoked.
- 6. This Order may be cited as "The Nottinghamshire County Council (Arnold Lane, Burton Road, Colliery Way (Gedling Access Road) and Lambley Lane, Gedling)(40mph Speed Limit and Restricted Road) Order 2022 (7223)" and shall come into force on the **22nd** day of **March 2022**.

SCHEDULE 1

- (i) Arnold Lane, Gedling in the Borough of Gedling from a point 31 metres south-east of its junction with Mapperley Plains in a south-easterly direction to a point 167 metres north-west of the outer perimeter of the roundabout junction with Colliery Way (Gedling Access Road).
- (ii) <u>Burton Road</u>, Gedling in the Borough of Gedling from its junction with Gedling Access Road in a south-westerly direction for a distance of 43 metres.
- (iii) Colliery Way (Gedling Access Road) (A6211), Gedling in the Borough of Gedling from a point 41 metres south-east of its junction with Mapperley Plains in a south-easterly direction to a point 123 metres north-west of the outer perimeter of the roundabout junction with Arnold Lane.

- (iv) Colliery Way (Gedling Access Road) (A6211), Gedling in the Borough of Gedling from a point 53 metres south-east of the outer perimeter of the roundabout junction with Waldrom Road in a south-easterly direction to its junction with Trent Valley Road (A612)
- (v) <u>Lambley Lane</u>, Gedling in the Borough of Gedling from its junction with Colliery Way (Gedling Access Road) in a north-easterly direction to a point 87 metres south-west of its junction with Spring Lane.

SCHEDULE 2

- (i) Arnold Lane, Gedling in the Borough of Gedling from a point 167 metres north-west of the outer perimeter of the roundabout junction with Colliery Way (Gedling Access Road) in a south-easterly direction to a point 68 metres south-east of the centre line of its junction with High Hazels Close.
- (ii) Colliery Way (Gedling Access Road) (A6211), Gedling in the Borough of Gedling from a point 123 metres north-west of the outer perimeter of the roundabout junction with Arnold Lane in an easterly direction to a point 53 metres south-east of the outer perimeter of the roundabout junction with Waldrom Road.
