

## <u>The Nottinghamshire County Council (Park Road, Bestwood)(Prohibition of</u> <u>Waiting) Traffic Regulation Order 2022 (7245)</u>

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council HAS MADE an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in Bestwood in the Borough of Gedling:-

No waiting at any time restrictions (double yellow lines) at the following locations:-

- 1. (i) <u>PARK ROAD (the north-west side)</u> from a point 56 metres north-east of its junction with St Albans Road in a northeasterly direction for a distance of 45 metres.
  - (ii) <u>PARK ROAD (the south-east side)</u> from a point 62 metres north-east of a point opposite the south-eastern kerb line of St Albans Road in a north-easterly direction to its junction with the entrance to the Bestwood Country Park car park.
  - (iii) <u>PARK ROAD BUS TURNING AREA (the north-west side)</u> from its south-western junction with Park Road in a north-easterly and then a southeasterly direction to its north-eastern junction with Park Road.
  - (iv) <u>PARK ROAD BUS TURNING AREA (the south-east side)</u> from its south-western junction with Park Road in a north-westerly, a north-easterly and then a south-easterly direction to its north-eastern junction with Park Road
- 2. <u>Other measures Bus Stop Clearway No Stopping at any time, except buses</u>

PARK ROAD BUS TURNING AREA – clearway approximately 29 metres long.

The double yellow lines are intended to remove parked vehicles from the area around the bus turning area on Park Road. The lines will help ensure that the bus can turn around and can stop adjacent to the kerbs to drop off and pick up passengers. In addition the restrictions will keep the bend clear and give vehicles pulling out of the Bestwood Country Park car park a clearer view along the road. The originally advertised double yellow lines on the north-west side of Park Road were shortened by 4 metres to allow on-street parking by local residents.
