

**The Nottinghamshire County Council (Emperors Way, Kenbrook Road, Paulina Avenue and Senator Close, Hucknall) (Prohibition of Waiting and No Stopping on Entrance Clearways) Traffic Regulation Order 2020 (4232)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council HAS MADE an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Hucknall in the District of Ashfield:-

**1. Vehicles will be prohibited from waiting at any time** along the following: -

**EMPERORS WAY, HUCKNALL** (the northern side)

- from a point 9 metres south-west of its junction with Senator Close in a north-easterly direction to a point 9 metres north-east of that junction

**EMPERORS WAY, HUCKNALL** (the southern side)

- from a point 102 metres south-east of its junction with Papplewick Lane in a south-easterly direction for 24 metres
- from a point opposite the south-western kerbline of Senator Close in a north-easterly direction for 50 metres

**KENBROOK ROAD, HUCKNALL** (the northern side)

- from a point opposite a point 32 metres north-east of its junction with Paulina Avenue in a north-easterly and then south-easterly direction around the bend for 45 metres

**KENBROOK ROAD, HUCKNALL** (the southern side)

- from a point 32 metres north-east of its junction with Paulina Avenue in a north-easterly and then south-easterly direction around the bend for 34 metres
- from a point 9 metres north-east of its junction with Paulina Avenue in a south-westerly direction to a point 10 metres south-west of that junction
- from a point 43 metres south-west of its junction with Paulina Avenue in a south-westerly direction for 32 metres

**PAULINA AVENUE, HUCKNALL** (both sides)

- from its junction with Kenbrook Road in a south-easterly direction for 10 metres

**SENATOR CLOSE, HUCKNALL** (both sides)

- from its junction with Emperors Way in a north-westerly direction for 10 metres

**2. Vehicles will be prohibited from waiting Monday to Friday, 8am-4.30pm** along the following: -

**KENBROOK ROAD, HUCKNALL** (the northern side)

- from a point opposite a point 32 metres north-east of its junction with Paulina Avenue in a south-westerly direction for 23 metres
- from a point opposite a point 15 metres south-west of its junction with Paulina Avenue in a south-westerly direction for 28 metres

**3. Vehicles will be prohibited from stopping on School Keep Clear Zigzags on Monday to Friday between 8am and 4.30pm** along the following:-

**EMPERORS WAY, HUCKNALL** (the southern side)

- from a point opposite a point 14 metres south-west of its junction with Emperors Way in a south-westerly and then north-westerly direction for 38 metres

**KENBROOK ROAD, HUCKNALL** (the north-west side)

- from a point opposite a point 9 metres north-east of its junction with Paulina Avenue in a south-westerly direction for 32 metres
- from a point opposite a point 43 metres south-west of its junction with Paulina Avenue in a south-westerly direction for 32 metres

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such as County Hall and libraries are closed or if reopened will have restrictions in place.
