

Road Traffic Regulation Act 1984

The Nottinghamshire County Council (Rose Way & Wheatcroft Drive, Edwalton) (Prohibition of Waiting and No Stopping on Entrance Clearways) Traffic Regulation Order 2020 (8298)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council HAS MADE an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Edwalton in the Borough of Rushcliffe: -

- Vehicles will be prohibited from waiting At Any Time along the following: -
 - ROAD BETWEEN SHARPHILL PRIMARY SCHOOL ENTRANCE AND ROSE WAY (both sides)
- (i) from its junction with the Sharphill Primary School entrance in a south-westerly & then a south-easterly direction to its junction with Rose Way.
- (ii) ROSE WAY (the north-east side) from a point 44 metres south-west of its junction with Wheatcroft Dr in south-easterly direction for 37m ROSE WAY (the north-west side)
- from a point 6 metres north-east of its junction with the entrance to the Sharphill Primary School in a south-westerly direction for a distance of 31 metres.

 ROSE WAY(the south-east side)
- (vi) from a point 7 metres north-east of a point opposite the north-eastern kerb line of the entrance to Sharphill Primary School in a south-westerly direction for a distance of 26 metres.
- from a point 10 metres north-east of its junction with Wheatcroft Drive in a south-westerly direction to a point 10 metres south-west of the same junction.
 ROSE WAY (the south-west side)
- (vi) from a point 44 metres south-west of a point opposite the south-western kerb line of Wheatcroft Drive in a south-easterly direction for a distance of 49 metres.
- (vii) SHARPHILL PRIMARY SCHOOL ENTRANCE (both sides)
 from its junction with Rose Way in a north-westerly direction for a distance of 12 metres.
 WHEATCROFT DRIVE (both sides)
- (viii) from its junction with Rose Way in a south-easterly direction for 7 metres.
- 2. <u>Vehicles will be prohibited from waiting on Monday to Friday between 8am and 4.30pm at the following locations:</u>
 - ROSE WAY (the south-east side)
- (i) from a point 10 metres north-east of its junction with Wheatcroft Dr in a north-easterly direction for 29 metres.
- (ii) from a point 10m south-west of its junction with Wheatcroft Dr in a south-westerly direction for 34 metres.
- Vehicles will be prohibited from stopping on school entrance markings on Monday to Friday between 8am and 4.30pm at the following locations: ROSE WAY (the north-east side)
- (i) From a point opposite a point 11 metres south-west of its junction with Wheatcroft Drive in a north-easterly direction to a point 18 metres south-west of its junction with the entrance to Sharphill Primary School (an approximate distance of 75 metres).

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such at County Hall and libraries are closed or if reopened will have restrictions in place.

The no waiting at any time restrictions will help ensure that the junctions and bends in the vicinity of the new school are kept clear of parked vehicles. The no stopping restrictions (School Keep Clear) and no waiting on Monday to Friday between 8am and 4.30pm restrictions will help to keep the road outside the school clear of vehicles during the school day making it safer for pupils attending the school.
