

**The Nottinghamshire County Council (A57 between Darlton and Dunham on Trent in Darlton, Dunham on Trent and Ragnal) (50mph Speed Limit) Order 2021 (1252)**

The Council of the County of Nottinghamshire ("the Council") in exercise of its powers under Sections 81, 82(2) and 83(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. No person shall drive any vehicle at a speed exceeding 50 miles per hour on that length of road in Darlton in the District of Bassetlaw as specified in the Schedule of this Order.
2. The length of road specified in the Schedule to this Order shall be revoked from the following Order "The Nottinghamshire County Council (A57 Darlton) (Various Speed Limits) Order 2016 (1179).
3. Any previous speed order made under the Road Traffic Regulation Act 1984 or any enactment replaced by that Act in so far as it is related to the lengths of road specified in the Schedule to this Order is hereby revoked.
4. This Order may be cited as " The Nottinghamshire County Council (A57 between Darlton and Dunham on Trent in Darlton, Dunham on Trent and Ragnal) (50mph Speed Limit) Order 2021 (1252)" and shall come into **force on the 13<sup>th</sup> day of December 2021.**

**Length of Roads at Darlton in the District of Bassetlaw**

A57 (Broad Gate), Darlton – extending from a point 396 metres west of its junction with the unnamed road that connects the A57 with Long Lane, East Drayton in an easterly direction to a point 14 metres south west of its junction with Low Street, Dunham-on-Trent.

Unnamed Road that connects the A57 with Long Lane, East Drayton – from its junction with the A57 in a northerly direction to a point 41 metres north of that junction.

Laneham Road, Dunham on Trent – from its junction with the A57 in a northerly direction to a point 25 metres north of that junction.

Upper Row, Dunham on Trent – from its junction with the A57 in a northerly direction to a point 19 metres north of that junction.

Main Street, Ragnall - from its junction with the A57 in a southerly direction to a point 67 metres south of that junction.
