

The Nottinghamshire County Council (Matlock Avenue Area, Mansfield) (Prohibition of Waiting) Traffic Regulation Order 2022 (2246)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council **HAS MADE** an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Mansfield in the District of Mansfield: -

Vehicles will be prohibited from Waiting At Any Time along the following lengths of road: -

<u>Cromford Avenue, Mansfield</u> (the north-east side)

From its junction with Matlock Avenue in a south-easterly direction for 13 metres.

Cromford Avenue, Mansfield (the east side)

From its junction with Hillsway Crescent in a north-westerly direction for 10 metres.

<u>Cromford Avenue, Mansfield</u> (the south-west side)

• From its junction with Matlock Avenue in a south-easterly direction for 14 metres.

<u>Cromford Avenue, Mansfield</u> (the west side)

• From its junction with Hillsway Crescent in a north-westerly direction for 10 metres.

Hillsway Crescent, Mansfield (the north-east side)

• From its junction with Matlock Avenue in a south-easterly direction for 10 metres.

<u>Hillsway Crescent, Mansfield</u> (the south-west side)

• From its junction with Matlock Avenue in a south-easterly direction for 11 metres.

<u>Hillsway Crescent, Mansfield</u> (the north side)

• From a point 10 metres west of its junction with Cromford Avenue in an easterly direction to a point 10 metres east of that junction.

Matlock Avenue, Mansfield (the eastern side)

- From its junction with Sheepbridge Lane in a north-westerly direction for 26 metres.
- From a point 11 metres north-east of its junction with Hillsway Crescent in a south-westerly direction to a point 11 metres south-west of that junction.

<u>Matlock Avenue, Mansfield</u> (the south-eastern side)

- From a point 13 metres north-east of its junction with Cromford Avenue in a south-westerly direction to a point 10 metres south-west of that junction.
- From a point 52 metres north-east of its junction with Cromford Avenue in a north-easterly direction for 23 metres.

Matlock Avenue, Mansfield (the western side)

- From its junction with Sheepbridge Lane in a north-westerly direction for 22 metres.
- From a point opposite a point 13 metres north-east of its junction with Cromford Avenue in a south-westerly direction for 32 metres

Matlock Avenue, Mansfield (the north- western side)

• From a point opposite a point 54 metres north- east of the north-east kerbline of Cromford Avenue in a north-easterly direction for 26 metres.

Sheepbridge Lane, Mansfield (the north side)

• From a point 20 metres north-west from the centre line with Matlock Avenue in a southeasterly direction to a point 14 metres south-east of the centre line of Matlock Avenue
