

<u>The Nottinghamshire County Council (Admiral Close, Cinnabar Way, Peacock Gardens, Sheepwash Way and Skipper Close, East Leake) (Prohibition and Restriction of Waiting and Entrance Clearways)</u> <u>Traffic Regulation Order 2022 (8343)</u>

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in East Leake in the Borough of Rushcliffe:-

1. Proposed No waiting at any time restrictions (double yellow lines) at the following locations:-

- (i) ADMIRAL CLOSE (both sides)
 - from its junction with Sheepwash Way in a north-easterly direction for 11 metres.
- (ii) <u>CINNABAR WAY (the north-west side)</u>
 - from its junction with Sheepwash Way in south-westerly direction for 6 metres.
 - CINNABAR WAY (the south-east side)
- (iii) from its junction with Sheepwash Way in south-westerly direction for 6 metres.
- (iv) from a point 10 metres south-west of its junction with Peacock Gardens in a north-easterly direction to a point 10 metres north-east of the same junction.

 PEACOCK GARDENS (the north-east side)
- (v) from a point 4 metres north-west of the projection of the north-western side of No.27 in a south-easterly and then a north-easterly direction to its north-eastern extremity.
- (vi) from its junction with Cinnabar Way in a south-easterly direction for 10 metres.
 - PEACOCK GARDENS (CUL DE SAC BETWEEN NUMBERS 6 AND 30) (both sides)
- (vii) from its junction with the north-west to south-east section of Peacock Gardens in a south-westerly direction for 10 metres.
 - PEACOCK GARDENS (the south-east side)
- (viii) from its north-eastern extremity in a south-westerly and then a north-westerly direction to its western extremity. <u>PEACOCK GARDENS (the south-west side)</u>
- (ix) from a point 2 metres south-east of the projection of the north-western side of No.27 in a south-westerly direction to its western extremity.
- (x) from a point 10 metres south-east of its junction with the cul-de sac between numbers 6 and 30 in a north-(xi(westerly direction to a point 10 metres north-west of the same junction.
- (xi) from its junction with Cinnabar Way in a south-easterly direction for 10 metres. SHEEPWASH WAY (north-east side)
- (xii) from a point 5 metres north-west of its junction with Admiral Close in a south-easterley direction to a point 6 metres south-east of the same junction.
- (xiii) from a point 10 metres north-west of its junction with Skipper Close in a south-easterley direction to a point 10 metres south-east of the same junction.
- (xiv) from a point 63 metres south-east of its junction with Skipper Close in a south-easterly and then a north-easterly direction to a point 2 metres north-west of its eastern extremity.
 SHEEPWASH WAY (south-west side)
- (xv) from a point 5 metres north-west of its junction with Cinnabar Way in a south-easterly direction to a point 6 metres south-east of the same junction.
- (xvi) from a point 53 metres south-east of a point opposite the south-eastern kerb line of Skipper Close in a south-easterly and then a south-westerly direction to a point 2 metres north-west of its south-eastern extremity.
 SKIPPER CLOSE (both sides)
- (xvii) from its junction with Sheepwash Way in a north-easterly direction for 7 metres.

Proposed No waiting Mon - Fri between 8am and 4.30pm (single yellow lines) at the following locations:-

- (i) <u>SHEEPWASH WAY (north-east side)</u>
 - from a point 57m south-east of its junction with Skipper Close in a south-easterly direction for 6m.
 - (ii) SHEEPWASH WAY (south-west side)
 - from a point 44 metres south-east of a point opposite the south-eastern kerb line of Skipper Close in a south-easterly direction for 9 metres.

Proposed No Stopping on Mon - Fri between 8am to 4.30pm on School Entrance Markings

(i) SHEEPWASH WAY (south-east side)

from a point 2 metres north-west of its south-eastern extremity in a south-easterly and then a north-easterly direction to a point 2 metres north-west of its eastern extremity.

The proposed parking restrictions are intended to keep the road clear of parked vehicles to help make the road safer for the users of the proposed new school to be located off the end of Sheepwash Way. The restrictions will help ensure that pedestrians can cross the road without having to negotiate parked vehicles. The school keep clear markings are located across the new school entrance and are intended to prohibit vehicles from stopping/parking during the school day.
