## VARIOUS ROADS IN SHEEPWASH WAY AREA, EAST LEAKE – PROPOSED PARKING RESTRICTIONS AND NO STOPPING ON SCHOOL KEEP CLEAR MARKINGS PUBLIC CONSULTATION – TRO 8343

Via East Midlands Ltd, working on behalf of Nottinghamshire County Council, is proposing to introduce parking and stopping restrictions in the area of Sheepwash Way, East Leake. The proposals are intended to remove parked and stopped vehicles to make it safer for pupils attending the new school located off the end of Sheepwash Way. The restrictions will keep the turning heads clear so that vehicles can turn around. This letter forms part of the public consultation which follows on from the initial consultation which was sent to local residents in June. As a result of the initial consultation additional double yellow lines are now proposed on Peacock Gardens – at the junction with the cul-de-sac between numbers 6 and 30 and at the junction with Cinnabar Way.

The proposed parking restrictions are at the following locations:-

- Junction of Sheepwash Way/Cinnabar Way/Admiral Close No waiting at any time (double yellow lines)
- Junction of Sheepwash Way/Skipper Close No waiting at any time (double yellow lines)
- Outside 43 Sheepwash Way No waiting on Monday to Friday between 8am and 4.30pm
- Outside garden of 64 Sheepwash Way No waiting on Monday to Friday between 8am and 4.30pm
- Bends at Sheepwash Way turning head No waiting at any time (double yellow lines)
- Turning head to Peacock Gardens No waiting at any time (double yellow lines)
- Junction of Peacock Gardens and cul-de-sac between numbers 6 and 30 No waiting at any time (double yellow lines)
- Junction of Peacock Gardens and Cinnabar Way No waiting at any time (double yellow lines)

In addition to the waiting restrictions it is proposed to introduce a school keep clear marking across the entrance to the new school located at the end of the turning head on Sheepwash Way. The restriction would prohibit stopping on Monday to Friday between 8am and 4.30pm.
