SHELFORD ROAD, RADCLIFFE-ON-TRENT (BETWEEN GRANDFIELD AVENUE & QUEENS ROAD) - PROPOSED ZEBRA CROSSING WITH RAISED JUNCTION PLATEAU AND SHELFORD ROAD, RADCLIFFE ON TRENT (BETWEEN PARK ROAD AND WAKEFIELD AVENUE) PROPOSED RAISED ZEBRA CROSSING – PUBLIC ADVERT

Via East Midlands Ltd, working on behalf of Nottinghamshire County Council is proposing to install a humped zebra crossing on Shelford Road (Radcliffe-on-Trent) between Grandfield Avenue and Queens Road approximately 6 metres north-east of its junction with Grandfield Avenue. In addition, a 75mm high junction table will extend over part of Shelford Road (for 55m), Grandfield Avenue (for 10.5m) and Queens Road (for 10.5m). In response to comments received during the initial consultation, the raised plateau has been extended slightly along Shelford Road to accommodate an existing driveway, as shown on drawing H/JW/4702/01.

The second proposed raised zebra crossing will also be located on Shelford Road between Park Road and Wakefield Avenue approximately 14 metres north-east of the junction with Park Road. The crossing will be located on a 9.5m long, 75mm high flat-topped hump (plateau) as shown on drawing H/JW/4703/01.

The crossings will have a controlled area, indicated by zig-zag markings, along the carriageway where stopping, parking and loading will be prohibited. They are being installed to improve pedestrian facilities and reduce traffic speeds on approaches to the proposed crossings on Shelford Road.

As required under Section 23 of the Road Traffic Regulation Act 1984 (zebra crossing) and Section 90A - 90I of the Highways Act 1980 (traffic calming hump), I hereby enclose for your attention the statutory public notice stating the County Council's intention to introduce the zebra crossings on Shelford Road and junction table on Shelford Road, Grandfield Avenue, Queens Road and the raised zebra crossing on Shelford Road between Park Road and Wakefield Avenue.

Further to the initial consultation letter of 24th June 2024, the next stage of the consultation is to publicly advertise the scheme. The notice will be published in the Nottingham Post and notices will be fixed on site. Plans showing the proposed crossings and raised plateaus are attached (Drawing Numbers H/JW/4702/01 and H/JW/4703/02) along with a copy of the site notice.
