

THE NOTTINGHAMSHIRE COUNTY COUNCIL (RAGNARS WALK, SOOKHOLME LANE, THE HAWTHORNS AND THORLEAF WAY, MARKET WARSOP) (STATIC RESTRICTIONS AND PROHIBITIONS) TRAFFIC REGULATION ORDER 2023 (2258)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Market Warsop in the District of Mansfield: -

Proposed prohibition of **Waiting At Any Time** along the following lengths of road: -

1. **RAGNARS WAY, MARKET WARSOP** (the east side)
 - (i) From its junction with Sookholme Lane in a southerly direction for 10 metres.
 - (ii) From a point opposite a point 4 metres south of its junction with Thorleaf Way in a northerly direction for a distance of 23 metres.
 - (iii) From a point opposite a point 50 metres south of its junction with Thorleaf Way in a southerly and then a south-easterly direction to the south-eastern extremity of the turning head.
2. **RAGNARS WAY, MARKET WARSOP** (the west side)
 - (i) From its junction with Sookholme Lane in a southerly direction for 10 metres.
 - (ii) From a point 10 metres south of its junction with Thorleaf Way in a northerly direction to a point 13 metres north of the same junction.
 - (iii) From a point 50 metres south of its junction with Thorleaf Way in a southerly, south-westerly and south-easterly direction to the south-eastern extremity of the turning head.
3. **SOOKHOLME LANE (MARKET WARSOP)** (the north side)
 - (i) From a point 10 metres west of its junction with The Hawthorns in an easterly direction to a point 10 metres east of the same junction.
4. **SOOKHOLME LANE (MARKET WARSOP)** (the south side)
 - (i) From a point 10 metres west of its junction with Ragnars Walk in an easterly direction to a point 10 metres east of the same junction.
5. **THE HAWTHORNS (MARKET WARSOP)** (both sides)
 - (i) From its junction with Sookholme Lane in a northerly direction for 10 metres.
6. **THORLEAF WAY (NORTH-EAST TO SOUTH-WEST SECTION)(MARKET WARSOP)**(the north-west side)
 - (i) From a point 43 metres south-west of its junction with Thorleaf Way (the south-east to north-west section) in a south-westerly, north-westerly and south-easterly direction to the south-eastern extremity of the turning head.
7. **THORLEAF WAY (NORTH-EAST TO SOUTH-WEST SECTION)(MARKET WARSOP)**(the south-east side)
 - (i) From a point 49 metres south-west of its junction with Thorleaf Way (the south-east to north-west section) in a south-easterly direction to the south-eastern extremity of the turning head.
8. **THORLEAF WAY (SOUTH-EAST TO NORTH-WEST SECTION)(MARKET WARSOP)** (Both sides)
 - (i) From its junction with Ragnars Walk in a westerly direction for a distance of 9 metres.
