Retford Railway Station Hotspot Resolution (TRO 1255)

Via East Midlands Ltd is working on behalf of Nottinghamshire County Council to deliver highway services. It is proposed to install double yellow lines (No Waiting at Any Time) and new Bus stop clearways (BSC), at the following locations-

- Queen Street (BA0990), Retford – 19 metre BSC north of its junction with Pelham Road - No Stopping, except buses
- Albert Road, Retford – Double yellow lines.
- Station Road, Retford – 15 metre BSC north west of its junction with Station Road - No Stopping, except buses and Double yellow lines.
- Victoria Road (BA0723), Retford – 15 metre BSC north of its junction with Station Road - No Stopping, except buses

The proposed double yellow lines are required to address issues with obstructive parking which is restricting visibility and impeding the movement of vehicles at these locations. The bus stop clearways are to be installed to prohibit other vehicles from stopping, parking or waiting in the bus stop at any time and will be clearly identified with new road markings and signage. The main benefits of bus stop clearways are required to:

- Help the bus align with the kerb to enable better access for disabled passengers and pushchair users.
- Ease congestion as a correctly aligned bus will not block the road for another road users.
- Ensure that bus drivers discharge their duty to drop passengers off on the kerb and not on the road.
- Ensure that bus services operate on time and are not unnecessarily delayed.

The proposal will be advertised, and notices displayed on site. A plan showing the proposals (drawing number H/GC/3564/01) is attached, along with a copy of the site notice.

Before proceeding further, I wish to consider the views of residents and organisations who may be interested in this matter. Any observations on these proposals should reach me in writing either by letter or email, by **14th January 2021**. If your comments are in the form of an objection to the proposals, please clearly state this and the reasons for your objection. If the objection cannot be resolved, it will be reported through the County Council's procedures at the appropriate time.
