

Road Traffic Regulation Act 1984

<u>The Nottinghamshire County (Bolsover St Hucknall) (Waiting Restrictions and Residents Parking Places) Traffic Regulation Order 2021 (4277)</u>

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads in Hucknall in the District of Ashfield -

1. Vehicles will be prohibited from waiting at any time along: -

BOLSOVER STREET, HUCKNALL (the north-east side)

- from a point 8 metres south-east of its junction with Station Road (including the turning head) in a south-easterly for 28 metres
- from a point 48 metres south-east of its junction with Station Road (including the turning head) in a south-easterly, then a south-westerly direction to a point 83 metres north east of its junction with Portland Road.

BOLSOVER STREET, HUCKNALL (the north-west side)

- from a point 90 metres north-east of its junction with Portland Road in a northeasterly, then north-westerly direction for 14 metres
- 2. Residents Parking Places: -

BOLSOVER STREET, HUCKNALL (the north-east side)

• from a point 36 metres south-east of its junction with Station Road (including the turning head) in a south-easterly for 12 metres

BOLSOVER STREET, HUCKNALL (the north-west side)

• from a point 42 metres north-east of its junction with Portland Road in a northeasterly direction for 48 metres

BOLSOVER STREET, HUCKNALL (the south-west side)

• from a point 30 metres south-east of its junction with Station Road in a southeasterly direction for 36 metres
