**THE NOTTINGHAMSHIRE COUNTY COUNCIL (A60 BETWEEN**  
**MANSFIELD WOODHOUSE AND WORKSOP) (50 M.P.H. SPEED LIMIT)**  
**ORDER 2018 (1224)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, the effects of which will be, in respects of roads at Spion Kop and Warsop in the District of Mansfield, Cuckney, Holbeck and Worksop in the district of Bassetlaw and Belph in the District of Bolsover:-

1. No person shall drive any vehicle at a speed exceeding 50 miles per hour on those lengths of road specified below:-

A60 Leeming Lane and A60 Mansfield Road (Spion Kop)

- (i) from a point 125 metres north-east of its junction with The Fairways in a north-easterly direction to a point 274 metres south-west of its junction with Mossar Close

A60 Mansfield Road (Warsop)

- (ii) from a point 120 metres north of its junction with Woodlands Way in a northerly direction to a point 110 metres south-west of its junction with Elmfield.

A60 Worksop Road (Cuckney), A60 Worksop Road (Holbeck), A60 Mansfield Road (Belph) and A60 Mansfield Road (Worksop)

- (iii) from a point 354 metres north of its junction with A616 Cresswell Road in a north-westerly then north-easterly direction to a point 70 metres north-east of the northern building line of Westwood Lodge.

2. Any previous speed limit order made under the Road Traffic Regulation Act 1984 or any enactment replaced by that Act in so far as it relates to the lengths of road specified above is hereby revoked.
