2019 (3292)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be on the following roads in Coddington in the District of Newark & Sherwood:-

1. to prohibit **waiting** "**At Any Time**" at the following location:-

Brownlow's Hill, Coddington (North Side)

From a point 10 metres east of its junction with Valley View in a westerly direction to its junction with Beckingham Road
