

The Nottinghamshire County Council (Chancery Lane, Coronation Street and Exchange Street, Retford) (Parking Places and Residents' Controlled Zone) (Prohibition of Waiting) Traffic Regulation Order 2021 (1261)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Retford in the District of Bassetlaw: -

Vehicles will be prohibited from waiting at any time at: -**CORNATION STREET (RETFORD) (the west side)**

- from its junction with Exchange Street in a south easterly direction for 20 metres
- from a point 35 metres south of its junction with Exchange Street to a point 101 metres west of its junction with Carolgate.

Vehicles will be prohibited from waiting Monday to Saturday 8am – 6pm at**EXCHANGE STREET (RETFORD) (the north side)**

- From a point 10 metres east of its western junction with Chancery Lane in an easterly direction for 47 metres.
- From a point 72 metres east of its western junction with Chancery Lane in an easterly direction to its eastern junction with Chancery Lane.

Vehicles will be allowed 1-hour parking (no return within 1 hour) Mon to Sat 8am – 6pm at**CHANCERY LANE (RETFORD) (the west side)**

- from a point 15 metres north of its junction with West Street in a northerly direction for 17 metres

CORNATION STREET (RETFORD) (the east side)

- from a point 25 metres south-east of its junction with Exchange Street in a south easterly direction for 17 metres

CORNATION STREET (RETFORD) (the west side)

- from a point 20 metres south-east of its junction with Exchange Street in a south easterly direction for 15 metres

EXCHANGE STREET (RETFORD) (the north side)

- from a point 57 metres east of its junction with Chancery Lane in an easterly direction for 15 metres

Revised Residents Controlled zone: -

CHANCERY LANE (RETFORD)

- from a point 32 metres north of its junction with West Street in a northerly direction to a point 15 metres south of a point opposite the projection of the southern kerb line of Exchange Street

SAVILE STREET (RETFORD)

Extended Residents Parking Bays: -

CHANCERY LANE (RETFORD) (west side)

- from a point 32 metres north of its junction with West Street in a northerly direction to a point 15 metres south of a point opposite the projection of the southern kerb line of Exchange Street.
