

**The Nottinghamshire County Council (Junctions off Mansfield Road, Skegby)
(Prohibition of Waiting) Traffic Regulation Order 2019 (4238)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Skegby in the District of Ashfield:-

Vehicles will be prohibited from **waiting at any time** along the following lengths of road: -

BINGHAM AVENUE, SKEGBY (both sides)

- From its junction with Mansfield Road in a south-westerly direction for 10 metres

CHANCERY CLOSE, SKEGBY (both sides)

- From its junction with Mansfield Road in a north-easterly direction for 10 metres

GREENFIELDS, SKEGBY (the south-east side)

- From its junction with Mansfield Road in a south-westerly direction for 10 metres

MANSFIELD ROAD, SKEGBY (the northern side)

- From a point 10 metres north-west of its junction with Chancery Close in a south-easterly direction to a point 10 metres south-east of that junction
- From a point 10 metres west of its junction with Omberley Avenue in an easterly direction to a point 10 metres east of that junction

MANSFIELD ROAD, SKEGBY (the southern side)

- From a point 10 metres north-west of its junction with Milner Street in a south-easterly direction to a point 10 metres south-east of that junction
- From a point 11 metres north-west of its junction with Greenfields in a south-easterly direction to a point 14 metres south-east of that junction
- From a point 12 metres north-west of its junction with Bingham Avenue in a south-easterly direction to a point 12 metres south-east of that junction

MILNER STREET, SKEGBY (both sides)

- From its junction with Mansfield Road in a south-westerly direction for 10 metres

OMBERLEY AVENUE, SKEGBY (both sides)

- From its junction with Mansfield Road in a northerly direction for 10 metres
