

THE NOTTINGHAMSHIRE COUNTY COUNCIL (GRANTHAM ROAD, ROPER STREET AND SAXONDALE DRIVE, RADCLIFFE ON TRENT) (PROPOSED PARKING RESTRICTIONS) TRAFFIC REGULATION ORDER 2025 (8397)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Radcliffe on Trent in the Borough of Rushcliffe: -

1. Proposed prohibition of Waiting At Any Time along the following lengths of road: -

GRANTHAM ROAD, (RADCLIFFE ON TRENT)

(the north-east side)

• From a point 18 metres north-west of its junction with A52, Grantham Road, in a north-westerly then northerly direction for 98 metres.

GRANTHAM ROAD, (RADCLIFFE ON TRENT)

(the south-west side)

• From its junction with Roper Street, in a north-westerly direction for 16 metres.

GRANTHAM ROAD, (RADCLIFFE ON TRENT)

(the west and south side)

• From a point 18 metres north-west of its junction with A52, Grantham Road, in a north-westerly then westerly direction for 74 metres.

ROPER STREET, (RADCLIFFE ON TRENT)

(the north-west side)

• From its junction with Grantham Road, in a south-westerly direction for 14 metres.

ROPER STREET, (RADCLIFFE ON TRENT)

- (the south-east side)
 - From its junction with Grantham Road, in a south-westerly direction for 14 metres.

SAXONDALE DRIVE, (RADCLIFFE ON TRENT)

(the north-east side)

• From a point 15 metres south-east of its junction with A52, Grantham Road, in a south-easterly direction for 8 metres.

SAXONDALE DRIVE, (RADCLIFFE ON TRENT)

(the south-west side)

• From a point 15 metres south-east of its junction with A52, Grantham Road, in a south-easterly direction for 10 metres.
