

The Nottinghamshire County (Greythorn Drive and Stowe Avenue, West Bridgford) (Prohibition of Waiting) Traffic Regulation Order 2020 (8308) and the provision of a zebra crossing

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, and under Section 23 of the Road Traffic Regulation Act 1984, the effects of which will be in respect of roads in West Bridgford in the Borough of Rushcliffe: -

1. Vehicles will be prohibited from waiting at any time along: -

GREYTHORN DRIVE (east side)

 From a point 8 metres north its junction with the entrance to Greythorn Primary School in a northerly direction for 8 metres

STOWE AVENUE (north side)

From its junction with Greythorn Drive in an easterly direction for 24 metres

STOWE AVENUE (south side)

From its junction with Greythorn Drive in an easterly direction for 29 metres

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council in exercise of its powers under Section 23 of the Road Traffic Regulation Act 1984 (Zebra crossing), proposes to install a zebra pedestrian crossing across Greythorn Drive in the Borough of Rushcliffe approximately 14 metres north of its junction with Stowe Avenue.

The crossing will incorporate a controlled area indicated by zig-zag markings along the carriageway where parking and loading will be prohibited. The extents of the controlled area are: -

GREYTHORN DRIVE (east side)

• From its junction with Stowe Avenue in a northerly direction for 36 metres.

GREYTHORN DRIVE (west side)

• From its junction with Stowe Avenue in a northerly direction for 34 metres.

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such as County Hall and libraries are closed or if reopened will have restrictions in place.

The crossing and double yellow lines are being installed to assist pedestrians, especially school children, in crossing the road and to address issues with obstructive parking which is restricting visibility and impeding the movement of vehicles at this location.
