Proposed Parking Restrictions and Bus Stop Clearway (TRO 1283)

Main Street, Scaftworth - PUBLIC ADVERT

Via East Midlands Ltd, is working on behalf of Nottinghamshire County Council to deliver Highway Services. Nottinghamshire County Council have received complaints that drivers are parking inconsiderately on Main Street, Scaftworth, which is causing issues with accessibility and can delay bus services as passengers have to walk out into the road to board. To help alleviate these problems it is proposed to introduce a new enforceable Bus Stop Clearway to be in operation Mon – Sat, 7am – 7pm.

The County Council works closely with all public transport operators across the County to identify bus stops that suffer from inconsiderate parking. At the location above, a bus stop clearway is to be installed that prohibit other vehicles from parking or waiting in the bus stop at the times specified and these will be clearly identified with new road markings and signage. The main benefits of bus stop clearway is to:

- Help the bus align with the kerb to enable better access for disabled passengers and pushchair users;
- Ease congestion as a correctly aligned bus will not block the road for other road users;
- Ensure that bus drivers discharge their duty to drop passengers off on the kerb and not on the road;
- Ensure that bus services operate on time and are not unnecessarily delayed.

It is also proposed to introduce 'No Waiting Mon – Sat, 7am – 7pm' restriction (Single Yellow Line) along a section of this road.

The proposals will be advertised, and notices displayed on site. A plan showing the proposals (Drawing number H/JW/4187/01) is attached, along with a copy of the site notice.
