

**THE NOTTINGHAMSHIRE COUNTY COUNCIL (A638 GREAT NORTH ROAD, BAULK LANE AND DANESHILL ROAD, TORWORTH) (30 M.P.H. AND 40MPH SPEED LIMITS) AND (RESTRICTED ROAD) ORDER 2024 (1285)**

The Council of the County of Nottinghamshire ("the Council") in exercise of its powers under Sections 81, 82(2), 83(2), 84(1) and 84(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. The length of road specified in Schedule 1 of this Order shall be a Restricted Road (30mph) for the purposes of Section 81 of the Act.
2. No person shall drive any vehicle at a speed exceeding 30 miles per hour on that length of road specified in Schedule 2 of this Order.
3. No person shall drive any vehicle at a speed exceeding 40 miles per hour on that length of road specified in Schedule 3 of this Order.
4. The following Orders are hereby revoked in so far as they relate to the lengths of road stated in the Schedules to this Order.
  - NOTTINGHAMSHIRE COUNTY COUNCIL (A638 GREAT NORTH ROAD, DANESHILL ROAD AND BAULK LANE, TORWORTH AND RANSKILL (40 M.P.H. SPEED LIMIT) ORDER 2007 (1040)
  - NOTTINGHAMSHIRE COUNTY COUNCIL (A638 GREAT NORTH ROAD, BARNBY MOOR AND TORWORTH) (40 M.P.H. & 50 M.P.H. SPEED LIMITS) ORDER 2018 (1204)
5. Any previous speed limit order made under the Road Traffic Regulation Act 1984, or any enactment replaced by that Act in so far as it related to the lengths of road specified in the Schedules to this Order is hereby revoked.
6. This Order may be cited as "THE NOTTINGHAMSHIRE COUNTY COUNCIL (A638 GREAT NORTH ROAD, BAULK LANE AND DANESHILL ROAD, TORWORTH) (30 M.P.H. AND 40MPH SPEED LIMITS) AND (RESTRICTED ROAD) ORDER 2024 (1285) and shall come into force on **7<sup>th</sup> June 2024**.

**SCHEDULE 1**

**A638 GREAT NORTH ROAD, TORWORTH**

From a point 22 metres north of its junction with Field View Gardens in a south-easterly direction to a point 130 metres south-east of its junction with Daneshill Road.

**BAULK LANE, TORWORTH**

From its junction with Great North Road in a westerly direction for 92 metres

**DANESHILL ROAD, TORWORTH**

From its junction with Great North Road in an easterly direction for 92 metres

## **SCHEDULE 2**

### **BAULK LANE, TORWORTH**

From a point 92 metres west of its junction with Great North Road in a westerly direction for 123 metres



### **DANESHILL ROAD, TORWORTH**

From a point 92 metres east of its junction with Great North Road in an easterly direction for 60 metres

## **SCHEDULE 3**

### **A638 GREAT NORTH ROAD, TORWORTH**

From a point 445 metres south of its junction with Daneshill Road in a south-easterly direction for 187 metres
