

THE NOTTINGHAMSHIRE COUNTY COUNCIL
(CONISTON ROAD AND KESWICK ROAD, WORKSOP)
(PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2023 (1291)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Worksop in the District of Bassetlaw: -

1. Vehicles will be **prohibited from Waiting At Any Time** along the following lengths of road: -

Coniston Road, Worksop (west side)

- From its junction with the north-west section of Keswick Road in a southerly direction for 10 metres.

Keswick Road, Worksop (north side)

- From its junction with the north-west section of Keswick Road in an easterly direction for 10 metres.

Keswick Road, Worksop (north and north-east side)

- From a point 6 metres west of the centre boundary line between properties 116 and 114 in an easterly and south-easterly direction for 28 metres.

Keswick Road, Worksop (north-west section) (north side)

- From its junction with Keswick Road in a westerly direction for 4 metres.

Keswick Road, Worksop (north-west section) (south and south-east side)

- From its junction with Keswick Road in a north-westerly and westerly direction for 11 metres.

2. Other Restrictions:- **Bus Stop Clearway – No Stopping At Any Time** on the following lengths of road:

Coniston Road, Worksop (south-west side)

- From a point 14 metres south-east of its junction with the south-west section of Coniston Road in a south-easterly direction for 19 metres.

Keswick Road, Worksop (north side)

- From a point 50 metres east of its junction with the north-west section of Keswick Road in an easterly direction for 19 metres.

Keswick Road, Worksop (north-east side)

- From a point 8 metres south-east of the south-east boundary line of property no. 100 in a north-westerly direction for 19 metres.
