**GRAFTON STREET, WORKSOP –
PROPOSED RESIDENTS' PARKING SCHEME (MON – SAT, 8AM – 6PM)
PUBLIC CONSULTATION – TRO 1293**

Via East Midlands is working on behalf of Nottinghamshire County Council to deliver highway services.

Nottinghamshire County Council have received requests to consider implementing a parking scheme to remove long-term non-residential parking from Grafton Street. In February and April 2023, questionnaires were sent to all affected residents to assess the level of support for a residents' parking scheme on Grafton Street between its junction with Gateford Road and numbers 45/46 Grafton Street. The questionnaires were sent to 58 residents of which 27 (47%) replied, of the responses 23 (85%) were in favour of the introduction of a residents' parking scheme. These results meet the criteria for the scheme to proceed to the formal consultation stage. The proposal is to introduce a residents parking scheme that would be in operation on Monday to Saturday between 8am and 6pm when a permit would be required to park on street. The existing single yellow lines (no waiting on all days from 8am to 6pm) at the junction with Gateford Road would be unaffected by the proposed residents' parking scheme.

The extents of the proposal are shown on the enclosed drawing (H/JAB/4136/100) and notice.

Before proceeding further, I wish to consider the views of residents, businesses and organisations who may be interested in this matter. Any observations on these proposals should reach me in writing, either by letter or email, by **21st August 2023**. If your comments are in the form of an objection to the proposals please clearly state this and the reasons for your objection. If the objection cannot be resolved, it will be reported through the County Council's procedures at the appropriate time.

The introduction of a residents' parking scheme would allow those residents and their visitors to continue parking on street; when displaying a valid permit. However, a permit would not guarantee a space directly outside a person's property and at busy times may not guarantee a space within the boundaries of the scheme.
