

# THE NOTTINGHAMSHIRE COUNTY COUNCIL (ASHVALE ROAD AND LINDEN AVENUE, TUXFORD) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2024 (1259A)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council Has Made an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Tuxford in the District of Bassetlaw: -

Prohibition from Waiting At Any Time along the following lengths of road: -

# **Ashvale Road, Tuxford** (the east side)

• From a point 12 metres south of its junction with Linden Avenue in a northerly direction to its junction with Lincoln Road.

# Ashvale Road, Tuxford (the west side)

• From a point opposite a point 12 metres south of its junction with Linden Avenue in a northerly direction to its junction with Lincoln Road..

# <u>Linden Avenue</u>, <u>Tuxford</u> (the north side)

• From its junction with Ashvale Road in a north-easterly direction for 20 metres

### Linden Avenue, Tuxford (the south side)

- From its junction with Ashvale Road in a north-easterly direction for 21 metres
- 2. Other Restrictions:- **Bus Stop Clearway No Stopping At Any Time** on the following lengths of road:

#### **Ashvale Road, Tuxford** (east side)

• From a point 38 metres south of its junction with Lincoln Road in a southerly direction for 19 metres.

### Ashvale Road, Tuxford (west side)

• From a point 56 metres south of its junction with Lincoln Road in a southerly direction for 19 metres.
