

**THE NOTTINGHAMSHIRE COUNTY COUNCIL (PORTLAND PLACE, SUTTON CUM
LOUND) (PROHIBITION OF WAITING AND NO STOPPING ON ENTRANCE
CLEARWAYS) TRAFFIC REGULATION ORDER 2025 (1322)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Sutton Cum Lound in the District of Bassetlaw: -

1. **Proposed prohibition of Waiting Mon – Fri 8am – 4.30pm** along the following length of road: -

Portland Place, Sutton Cum Lound (north-east side)

- From a point opposite a point 8 metres north of the northern kerb line of Portland Meadows in a south-easterly direction for 29 metres.
2. Vehicles will be **Prohibited from Stopping Mon – Fri 8am – 4.30pm** along the following length of road:

Portland Place, Sutton Cum Lound (south-east side)

- From a point opposite a point 14 metres south-east of the south-eastern kerb line of Portland Meadows in a south-easterly direction 27 metres.
