

**The Nottinghamshire County Council (Junctions off Big Barn Lane, Mansfield)
(Prohibition of Waiting) Traffic Regulation Order 2018 (2212)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in Mansfield in the District of Mansfield:-

Vehicles will be prohibited from Waiting At Any Time along the following: -

BIG BARN LANE, MANSFIELD (the east side)

- from its junction with Eakring Road in a southerly direction for a distance of 40 metres

BIG BARN LANE, MANSFIELD (the south-east and north-west sides)

- from its junction with Southwell Road West in a north-easterly direction for a distance of 16 metres

BIG BARN LANE, MANSFIELD (the west side)

- from its junction with Eakring Road in a southerly direction for a distance of 47 metres

CLIFTON GROVE, MANSFIELD (both sides)

- from its junction with Southwell Road West in a south-westerly direction for a distance of 17 metres

EAKRING ROAD, MANSFIELD (the north side)

- from a point 20 metres west of its junction with Pump Hollow Lane in an easterly direction to a point 44 metres east of that junction

EAKRING ROAD, MANSFIELD (the south side)

- from a point 18 metres west of its junction with Big Barn Lane in an easterly direction to a point 24 metres east of that junction

PUMP HOLLOW LANE, MANSFIELD (the east side)

- from its junction with Eakring Road in a northerly direction for a distance of 25 metres

PUMP HOLLOW LANE, MANSFIELD (the west side)

- from its junction with Eakring Road in a northerly direction for a distance of 23 metres

SOUTHWELL ROAD WEST, MANSFIELD (the north-east side)

- from a point 15 metres north-west of its junction with Big Barn Lane in a south-easterly direction to a point 18 metres south-east of that junction

SOUTHWELL ROAD WEST, MANSFIELD (the south-west side)

- from a point 15 metres north-west of its junction with Clifton Grove in a south-easterly direction to a point 24 metres south-east of that junction

SOUTHWELL ROAD WEST (SERVICE ROAD), MANSFIELD (the north-east side)

- from its junction with Clifton Grove in a north-westerly direction for a distance of 8 metres

SOUTHWELL ROAD WEST (SERVICE ROAD), MANSFIELD (the south-west side)

- from its junction with Clifton Grove in a north-westerly direction for a distance of 10 metres
