**THE NOTTINGHAMSHIRE COUNTY COUNCIL (B6014 SKEGBY LANE,
MANSFIELD AND SUTTON IN ASHFIELD) (30 M.P.H. SPEED LIMIT)**
RESTRICTED ROAD ORDER 2023 (2251)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council **Has Made** an order under the Road Traffic Regulation Act 1984, the effects of which will be, in respects of roads at Mansfield and Sutton in Ashfield in the Districts of Ashfield and Mansfield in the County of Nottinghamshire.

1. The length of road specified in the Schedule of this Order shall be a Restricted Road (30mph) for the purposes of Section 81 of the Act.

B6014 SKEGBY LANE, MANSFIELD AND SUTTON IN ASHFIELD

- From a point 70 metres east of its junction with the A6075 Kings Mill Road / Beck Lane in an easterly direction to the boundary between the District of Ashfield and the District of Mansfield.
- From the boundary between the District of Ashfield and the District of Mansfield in an easterly direction to a point 107 metres west of the centre line of its junction with Ladybrook Lane.

2. The following Order is hereby revoked in so far as they relate to the length of road specified in the Schedule to this Order: -

3. Any previous speed limit order made under the Road Traffic regulation Act 1984 or any enactment replaced by that Act in so far as it related to the lengths of road specified in the Schedule to this Order is hereby revoked.
