

THE NOTTINGHAMSHIRE COUNTY COUNCIL (A6191 SOUTHWELL ROAD WEST, A617 MILLENNIUM WAY, A617 SHERWOOD WAY EAST, B6020 SOUTHWELL ROAD EAST, RATCHER HILL AND SHERWOOD AVENUE, MANSFIELD) (40MPH SPEED LIMIT) ORDER 2024 (2266)

The Council of the County of Nottinghamshire ("the Council") in exercise of its powers under Sections 81, 82(2), 83(2), 84(1) and 84(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. No person shall drive any vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in the Schedule of this Order.
2. The following Orders are hereby revoked in so far as they relate to the lengths of road stated in the Schedule to this Order.
 - NOTTINGHAMSHIRE COUNTY COUNCIL (RAINWORTH BYPASS, KIRKLINGTON ROAD AND SOUTHWELL ROAD WEST, RAINWORTH AND RUFFORD (SPEED LIMITS) ORDER 2000 (2074)
 - NOTTINGHAMSHIRE COUNTY COUNCIL (A6191 (SOUTHWELL ROAD WEST, MANSFIELD)) (VARIOUS SPEED LIMITS) ORDER 2015 (2184)
 - NOTTINGHAMSHIRE COUNTY COUNCIL (MANSFIELD ASHFIELD REGENERATION ROUTE) (SPEED LIMITS) ORDER 2004 (4069A)
3. Any previous speed limit order made under the Road Traffic Regulation Act 1984, or any enactment replaced by that Act in so far as it related to the lengths of road specified in the Schedules to this Order is hereby revoked.
4. This Order may be cited as "THE NOTTINGHAMSHIRE COUNTY COUNCIL (A6191 SOUTHWELL ROAD WEST, A617 MILLENNIUM WAY, A617 SHERWOOD WAY EAST, B6020 SOUTHWELL ROAD EAST, RATCHER HILL AND SHERWOOD AVENUE, MANSFIELD) (40MPH SPEED LIMIT) ORDER 2024 (2266) and shall come into force on xx xxxx 2024.

SCHEDULE

A6191 SOUTHWELL ROAD WEST, MANSFIELD

From a point 39 metres north-west of its junction with Anglia Way in a south-easterly direction to its junction with B6020 Southwell Road East.

A617 MILLENNIUM WAY (RAINWORTH BYPASS), MANSFIELD

From its junction with the A617 Millennium Way/B6020 Southwell Road East Roundabout in a north-easterly direction for 104 metres

A617 SHERWOOD WAY EAST, MANSFIELD

From its junction with the A617 Millennium Way/B6020 Southwell Road East Roundabout in a south-westerly direction for 158 metres

B6020 SOUTHWELL ROAD EAST, MANSFIELD

From its junction with the with the A617 Millennium Way/B6020 Southwell Road East Roundabout in a south-easterly direction for 81 metres

RATCHER HILL, MANSFIELD

From its junction with the A6191 roundabout in a north-easterly direction for 21 metres

SHERWOOD AVENUE, MANSFIELD

From its junction with B6020 Southwell Road West in a south-westerly direction for 22 metres
