**ALBERT STREET, MANSFIELD WOODHOUSE - PROPOSED PARKING RESTRICTIONS AND
BUS STOP CLEARWAY (TRO 2269) PUBLIC ADVERT**

Via East Midlands Ltd, is working on behalf of Nottinghamshire County Council to deliver highway services in Nottinghamshire. Concerns have been raised about inconsiderate and obstructive parking along High Street outside the entrance to the Church/Nursery Car Park.

Further to the initial consultation letter of 18th March 2024, we have evaluated the issues and it has been decided to make some changes to the original proposals.

The revised proposals consist of the following:

- Add a bus stop clearway on the east side of Albert Street
- Extend the proposed double yellow lines further on the west side of Albert Street to the existing lines and to extend the double yellow lines on the east side of Albert Street to the bus stop clearway.

The County Council works closely with all public transport operators across the County to identify bus stops that suffer from inconsiderate parking. At the location above a bus stop clearway is to be installed that prohibits other vehicles from parking or waiting in the bus stops at the times specified and these will be clearly identified with new road markings and signage. The main benefits of bus stop clearways is to:

- Help the bus align with the kerb to enable better access for disabled passengers and pushchair users;
- Ease congestion as a correctly aligned bus will not block the road for other road users;
- Ensure that bus drivers discharge their duty to drop passengers off on the kerb and not on the road;
- Ensure that bus services operate on time and are not unnecessarily delayed.

The next stage of the consultation is to publicly advertise the scheme. The advert will be published in the Mansfield Chad and notices will be fixed on site. A plan showing the extents of the 'No Waiting At Any Time' restrictions (Double Yellow Lines) is attached (Drawing Number H/CLW/4586/01 Rev A along with a copy of the Site Notice.
