



**THE NOTTINGHAMSHIRE COUNTY COUNCIL (A1 SLIP ROAD,  
BECKINGHAM ROAD AND NEWARK ROAD, CODDINGTON)  
(40 MPH SPEED LIMIT) ORDER 2024 (3304)**

The Council of the County of Nottinghamshire ("the Council") in exercise of its powers under Sections 81, 82(2), 83(2), 84(1) and 84(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. No person shall drive any vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in the Schedule of this Order.
2. The following Order is hereby revoked in so far as it relates to the length of road specified in the Schedule to this Order:-
  - "THE NOTTINGHAMSHIRE COUNTY COUNCIL (BEACON HILL ROAD, NEWARK ON TRENT AND BECKINGHAM ROAD, CODDINGTON) (40M.P.H. AND 50M.P.H. SPEED LIMITS) ORDER 2014 (3207)"
3. Any previous speed limit order made under the Road Traffic Regulation Act 1984 or any enactment replace by that Act in so far as it related to the lengths of road specified in the Schedules to this Order is hereby revoked.
4. This Order may be cited as

"THE NOTTINGHAMSHIRE COUNTY COUNCIL (A1 SLIP ROAD, BECKINGHAM ROAD AND NEWARK ROAD, CODDINGTON) (40 MPH SPEED LIMIT) ORDER 2024 (3304)" and shall come into force on the **xx** day of **xxxxxxxx** 2024.

**SCHEDULE**

**1. BECKINGHAM ROAD, CODDINGTON**

From the junction of Beacon Hill Road and Newbury Road in a north-easterly direction to a point 71 metres north-east of its junction with the A1 Slip Road

**2. A1 SLIP ROAD, CODDINGTON**

From its junction with Beckingham Road in a northerly, then north westerly direction for 145 metres

**3. NEWARK ROAD, CODDINGTON**

From its junction with A1 Sip Road in a northerly direction for 81 metres
