

**THE NOTTINGHAMSHIRE COUNTY COUNCIL (BLIDWORTH ROAD,  
CHURCH SIDE AND MAIN STREET, FARNSFIELD)  
(PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2023 (3364)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Farnsfield in the District of Newark and Sherwood: -

Vehicles will be **prohibited from Waiting At Any Time** along the following lengths of road: -

**BLIDWORTH ROAD, FARNSFIELD** (the south side)

- From its junction with Church Side in a westerly direction for 10 metres.

**BLIDWORTH ROAD, FARNSFIELD** (the south-east side)

- From its junction with Church Side in a north-easterly direction to its junction with The Green.

**CHURCH SIDE, FARNSFIELD** (the east side)

- From its junction with Blidworth Road in a southerly direction for 14 metres.

**CHURCH SIDE, FARNSFIELD** (the south-east side)

- From its junction with Blidworth Road in an easterly direction for 8 metres

**MAIN STREET, FARNSFIELD** (the south side)

- From a point 2 metres west of its junction with Eaton Close in an easterly direction to a point 5 metres east of this junction
- From a point opposite a point 13 metres north-west of the western kerblines of The Ridgeway in a south-easterly direction for 45 metres.
