

**THE NOTTINGHAMSHIRE COUNTY COUNCIL**  
**(BEACON HILL ROAD AND CROSS STREET, NEWARK ON TRENT)**  
**(PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2023 (3372)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Newark on Trent in the District of Newark and Sherwood: -

Proposed **prohibition of Waiting At Any Time** along the following length of road: -

**Beacon Hill Road, Newark on Trent** (north side)

- From a point 5 metres west of its junction with Hatton Grove in an easterly direction to a point 5 metres east of that junction.
- From a point 14 metres west of its junction with The Ropewalk in an easterly direction to a point 10 metres east of that junction.

**Cross Street, Newark on Trent** (north-west side)

- From a point 15 metres south-west of the centre line of its junction with Kingsnorth Close in a north-easterly direction for 30 metres.

**Cross Street, Newark on Trent** (south-east side)

- From a point 10 metres south-west of its junction with Massey Street in a north-easterly direction to a point 5 metres north-east of that junction.

**Kingsnorth Close, Newark on Trent** (both sides)

- From its junction with Cross Street in a north-westerly direction for 10 metres.

**Massey Street, Newark on Trent** (both sides)

- From its junction with Cross Street in a south-easterly direction for 10 metres.

**The Ropewalk, Newark on Trent** (both sides)

- From its junction with Beacon Hill Road in a northerly direction for 18 metres.
