**THURGARTON) (PROHIBITION OF WAITING) TRAFFIC REGULATION**  
**ORDER 2025 (3394)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Thurgarton in the Newark and Sherwood District: -

**Proposed prohibition of Waiting At Any Time** along the following lengths of road: -

**Southwell Road, Thurgarton** (the north-west side)

- From its junction with The Hollowes in north-easterly direction for 10 metres.

**The Hollowes, Thurgarton** (the north side)

- From its junction with Southwell Road in a westerly direction for 17 metres.

**The Hollowes, Thurgarton** (the south side)

- From its junction with Nottingham Road in a westerly direction for 28 metres.
