

**THE NOTTINGHAMSHIRE COUNTY COUNCIL**  
**(FOSSE ROAD, EAST STOKE, ELSTON AND SYERSTON AND FOSSE WAY, FLINTHAM)**  
**(40 MPH AND 50MPH SPEED LIMITS) ORDER 2025 (3404)**

The Council of the County of Nottinghamshire ("the Council") in exercise of its powers under Sections 81, 82(2), 83(2), 84(1) and 84(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. No person shall drive any vehicle at a speed exceeding 40 miles per hour on that length of road specified in Schedule 1 of this Order.
2. No person shall drive any vehicle at a speed exceeding 50 miles per hour on the length of road specified in Schedule 2 of this Order.
3. The following Orders are hereby revoked in so far as they relate to the lengths of road specified in the Schedules to this Order:-
  - a. THE NOTTINGHAMSHIRE COUNTY COUNCIL (FOSSE ROAD, EAST STOKE) (30MPH SPEED LIMIT) ORDER 2016 (3226)
  - b. THE NOTTINGHAMSHIRE COUNTY COUNCIL (C255 FOSSE ROAD AND LODGE LANE, ELSTON) (DERESTRICTION) ORDER 2012 (3158)"
  - c. THE A46 TRUNK ROAD (FOSSE WAY, NOTTINGHAMSHIRE) (DESRESTRICTION) ORDER 2000"
  - d. THE NOTTINGHAMSHIRE COUNTY COUNCIL (C102 INHOLMES ROAD, FLINTHAM) (RESTRICTED ROAD) ORDER 1980"
4. Any previous speed limit order made under the Road Traffic Regulation Act 1984, or any enactment replaced by that Act in so far as it related to the lengths of road specified in the Schedules to this Order is hereby revoked.
5. This Order may be cited as "THE NOTTINGHAMSHIRE COUNTY COUNCIL (FOSSE ROAD, EAST STOKE, ELSTON AND SYERSTON AND FOSSE WAY, FLINTHAM) (40 MPH AND 50MPH SPEED LIMITS) ORDER 2025 (3404) and shall come into force on xx xxxx 2025.

**SCHEDULE 1**

**FOSSE ROAD, EAST STOKE**

- From its junction with Fosse Road, Elston in a north-easterly direction to a point 126 metres south-west of its junction with School Lane.

**FOSSE ROAD, ELSTON**

- From a point 28 metres south-west of its junction with Elston Lane in a north-easterly direction to its junction with Fosse Road, East Stoke.

## **SCHEDULE 2**

### **FOSSE ROAD, ELSTON**

- From its junction with Fosse Road, Syerston in a north-easterly direction to a point 28 metres south-west of its junction with Elston Lane.

### **FOSSE WAY, FLINTHAM**

- From its junction with Un-named Road in a north-easterly then south-easterly then north-easterly direction to its junction with Fosse Road, Syerston.

### **FOSSE ROAD, SYERSTON**

- From its junction with Fosse Way Flintham in a north-easterly direction to its junction with Fosse Road, Elston.
