

## The Nottinghamshire County Council (Bird's Lane, Main Road and Swifts View, Kirkby Woodhouse) (Prohibition of Waiting) Traffic Regulation Order 2017 (4201)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Kirkby Woodhouse in the District of Ashfield:-

1. Vehicles will be prohibited from waiting at any time along the following : -

## BIRD'S LANE, (KIRKBY WOODHOUSE) (both sides)

• from its junction with Main Road in a south-westerly direction for a distance of 14 metres.

MAIN ROAD, (KIRKBY WOODHOUSE) (the south-west side)

- from a point 16 metres north-west of its junction with Bird's Lane, in a south-easterly direction to a point 31 metres south-east of that junction.
- from a point opposite a point 38 metres north-west of its junction with Mill Lane in a south-easterly direction for a distance of 156 metres to a point 12 metres south-east of its junction with Swifts View.

SWIFTS VIEW (KIRKBY WOODHOUSE) (both sides)

- from its junction with Main Road in a south-westerly direction for a distance of 10 metres.
- 2. Vehicles will be prohibited from **waiting Monday Friday, from 8am 4.30pm** along the following : -

MAIN ROAD, (KIRKBY WOODHOUSE) (the north-east side)

- from a point opposite a point 16 metres north-west of its junction with Bird's Lane in a south-easterly direction for a distance of 261 metres to a point 30 metres north-west of its junction with Mill Lane.
- from a point 22 metres south-east of its junction with Mill Lane in a south-easterly direction for a distance of 44 metres.
- 3. Other restrictions **Bus Stop Clearways** No stopping, except buses, at any time

## MAIN ROAD (KIRKBY WOODHOUSE)

• Four bus stops between Bird's Lane and Swifts View – AS0272, AS0273, AS0274, AS0275
