

<u>The Nottinghamshire County Council</u> (Abbey Road, Chartwell Road and Glenside, Kirkby-in-Ashfield) (Prohibition of Waiting) Traffic Regulation Order 2018 (4213)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Kirkby-in-Ashfield in the District of Ashfield:-

1. Vehicles will be prohibited from waiting at any time along the following lengths of road: -

<u>ABBEY ROAD (KIRKBY-IN-ASHFIELD)</u> (the north side)

• from a point 18 metres east of its junction with Glenside in a westerly direction to a point 17 metres west of that junction

ABBEY ROAD (KIRKBY-IN-ASHFIELD) (the south side)

• from a point 18 metres east of its junction with Chartwell Road in a westerly direction to a point 16 metres west of that junction

CHARTWELL ROAD (KIRKBY-IN-ASHFIELD) (both sides)

• from its junction with Abbey Road in a southerly direction for 12 metres

<u>GLENSIDE (KIRKBY-IN-ASHFIELD)</u> (both sides)

- from its junction with Abbey Road in a northerly direction for 15 metres
- Other restrictions bus stop clearways no stopping, except buses, at any time <u>GLENSIDE (KIRKBY-IN-ASHFIELD)</u>
 - Bus stops AS0289 and AS0290 introduce 19 metre long bus stop clearways
