

**THE NOTTINGHAMSHIRE COUNTY COUNCIL (B6021 KIRKBY  
FOLLY ROAD AND LOWMOOR ROAD, SUTTON IN ASHFIELD) (30  
M.P.H. SPEED LIMIT) (RESTRICTED ROAD) ORDER 2023 (4288)**

The Council of the County of Nottinghamshire ("the Council") in exercise of its powers under Sections 81, 82(2), 83(2), 84(1) and 84(2) of the Road Traffic Regulation Act 1984 ("the 1984 Act"), and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. The length of road specified in the Schedule of this Order shall be a Restricted Road (30mph) for the purposes of Section 81 of the Act.
2. The following Order is hereby revoked in so far as it relates to the length of road stated in the Schedule to this Order.

3. Any previous speed limit order made under the Road Traffic Regulation Act 1984, or any enactment replaced by that Act in so far as it related to the lengths of road specified in the Schedules to this Order is hereby revoked.
4. This Order may be cited as "THE NOTTINGHAMSHIRE COUNTY COUNCIL (B6021 KIRKBY FOLLY ROAD AND LOWMOOR ROAD, SUTTON IN ASHFIELD) (30 M.P.H. SPEED LIMIT) (RESTRICTED ROAD) ORDER 2023 (4288)" and shall come into force on xx xxxx 2023.

- From a point 46 metres south-west of its junction with B6022 Station Road in a south-westerly direction to its junction with Maun View Gardens

**B6021 LOWMOOR ROAD, SUTTON IN ASHFIELD**

- From its junction with Maun View Gardens a south-westerly direction to a point 12 metres south-west of that junction
