

<u>THE NOTTINGHAMSHIRE COUNTY COUNCIL</u> (STONEYFORD ROAD, SUTTON IN ASHFIELD) (PROHIBITION OF WAITING) <u>TRAFFIC REGULATION ORDER 2024 (4303)</u>

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Sutton in Ashfield in the District of Ashfield: -

1. Proposed prohibition of Waiting At Any Time along the following lengths of road: -

Carsic Road, Sutton in Ashfield (the north-west side)

- From its junction with Stoneyford Road in a south-westerly direction for 11 metres.
- Carsic Road, Sutton in Ashfield (the south-east side)
- From its junction with Stoneyford Road in a south-westerly direction for 10 metres.
- Stoneyford Road, Sutton in Ashfield (the north-east side)
 - From a point 15 metres north-west of its junction with Quarrydale Road in a south-easterly direction to a point 10 metres south-east of that junction
- Stoneyford Road, Sutton in Ashfield (the south-west side)
 - From a point 10 metres north-west of its junction with Carsic Road in a south-easterly direction to a point 10 metres south-west of that junction
- Quarrydale Road, Sutton in Ashfield (the north-west side)
 - From its junction with Stoneyford Road in a north-easterly direction for 11 metres.
- Quarrydale Road, Sutton in Ashfield (the south-east side)
 - From its junction with Stoneyford Road in a north-easterly direction for 12 metres.
- 2. Other restrictions: **Bus Stop Clearways** No Stopping, except Buses on the following length of road:

Stoneyford Road, Sutton in Ashfield (the north-east side)

• From a point 15 metres north-west of its junction with Quarrydale Road in a north-westerly direction for 19 metres.
