

**THE NOTTINGHAMSHIRE COUNTY COUNCIL  
(STONEYFORD ROAD, SUTTON IN ASHFIELD) (PROHIBITION OF WAITING)  
TRAFFIC REGULATION ORDER 2023 (4304)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Sutton in Ashfield in the District of Ashfield: -

1. Proposed **prohibition of Waiting At Any Time** along the following lengths of road: -

**Stoneyford Road, Sutton in Ashfield** (the north-east side)

- From a point 63 metres north-west of its junction with Mistletoe Way in a south-easterly direction to a point 10 metres south-east of that junction.
- From a point 29 metres south-east of its junction with Mistletoe Way in a south-easterly direction for 78 metres.

**Stoneyford Road, Sutton in Ashfield** (the south-west side)

- From its junction with Carsic Road in a north-westerly direction for 25 metres.
- From a point 44 metres north-west of its junction with Carsic Road in a north-westerly direction for 63 metres.

2. Other Restrictions:- **Bus Stop Clearway – No Stopping At Any Time Except Buses** on the following length of road:

**Stoneyford Road, Sutton in Ashfield** (the north-east side)

- From a point 10 metres south-east of its junction with Mistletoe Way in a south-easterly direction for 19 metres.

**Stoneyford Road, Sutton in Ashfield** (the south-west side)

- From a point 25 metres north-west of its junction with Carsic Road in a north-westerly direction for 19 metres.
